To register for pool tags, please follow these steps:

1. The 2010 assessment and all prior year assessments must be paid in full. You must be a member in good standing to register for the pool.
2. If you have your ID Tags from last year, enclose them with the form completed and return to the address below. If you need to replace tags or have a new addition to your family, then complete the attached form including their information and return along with photo's.
3. Mail the enclosed form, along with your last year tags, to **CONSOLIDATED MANAGEMENT SERVICES, 2204 TIMBERLOCH PLACE, SUITE 245, THE WOODLANDS, TEXAS 77380**. Please note that processing can take up to two weeks.
4. All forms received **after June 15, 2010** will be assessed a \$5.00 late charge made payable to **CONSOLIDATED MANAGEMENT SERVICES** for services performed for late registration!!!

**NOTE: The pool is closed on Mondays. The pool will be open on Memorial Day and Labor Day. The pool will be closed the Tuesday after Memorial Day. Labor Day will be the last day of the pool season.**

## **THE COLONIES RECREATION & P.O.A.**

### **GENERAL POOL RULES**

1. No one will be admitted without proper photo I. D.
2. All children under 10 years of age must be accompanied by an adult 18 years or older.
3. Members who have guests must sign them in and be responsible for them at all times. Guest passes can be purchased at a cost of \$2.00 per entry per guest. **Must have exact change.** Residents must pay guest fee if proper ID is not available.
4. Proper swimming attire is required. No jeans or cloth shorts. White T-Shirts only.
5. Lifeguards are not responsible for the supervision of the baby pool.
6. The use of cocoa butter, baby oil, and other heavy suntan oils cause filter damage. It is advised that these lotions not be permitted in the pool.
7. Only small floating items will be allowed in the pool.
8. No glass containers or alcoholic beverages are allowed in the pool area.
9. **Absolutely no foul or abusive language will be permitted.**
10. No pets are permitted on pool premises.
11. No loud music around the pool area.
12. No running or rough play will be allowed.
13. No swimming after designated swimming hours, unless special arrangements have been made through the Board of Directors or the Management Company.
14. All swimmers must dive straight out and not off to the side of the diving boards.
15. Only one person allowed on diving board at one time. No swimming is allowed in designated areas of the pool while the diving board is in use.
16. No diving in shallow end of pool (less than 5 feet).
17. The Colonies Recreation & POA or pool management is not responsible for items lost or left in the pool area.
18. Lifeguards on duty have final authority on matters of conduct.
